- Philosophy Statement

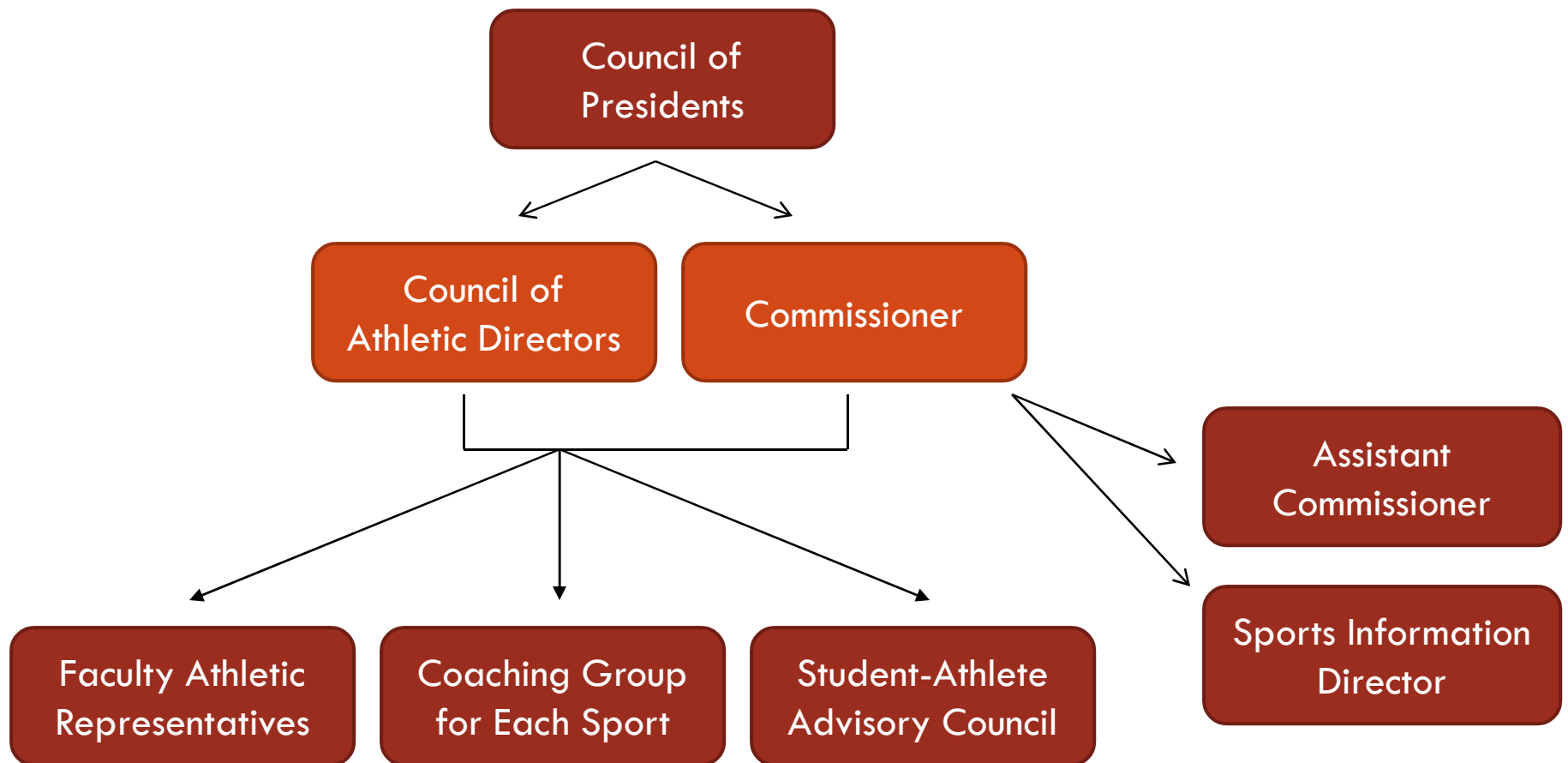

- Council of Presidents
  - Ultimate authority for the conference
  - Meet in person once per year in March
  - Authority to act on all conference matters
  - Approve UMAC operating budget
  - Steer long-range strategic planning
  - Northwestern College President, Dr. Alan S. Cureton
    - Current Chair of the Council of Presidents

- Responsible for day-to-day operations and activities of the conference (Chief Administrative Officer)
- NCAA liaison
- Strategic planning
- Development of sport schedules and championships
- Oversight of conference officials and assignors

- Facilitation of conference awards programs
- Budget development and management
- Public relations and marketing

  - ▣ Conference director of championships

# UMAC History

---

- ❑ Created in 1972 as the Twin Rivers Conference
- ❑ Renamed to current title in 1983
- ❑ Previously a non-scholarship NAIA conference
- ❑ Began transition to NCAA Division III in 2002
- ❑ Received NCAA Division III conference membership status starting in 2008-2009 academic year
- ❑ Automatic qualifier (“AQ”) for applicable team sports will begin with 2010-2011 academic year
